- 1) Classroom Sessions are offered monthly at various locations throughout the province. This 10 day session is offered over two consecutive weeks (Monday – Friday, 9:00am to 5:00pm), or over 4 weekends (1st and last weekend, Friday, Saturday, Sunday, 9:00am to 5:00pm; 2nd and 3rd weekends – Saturday and Sunday only, 9:00am to 5:00pm).
- 2) A three hour exam must be written (see course schedule at www.nbrea.ca) after the completion of the entire course. The pass mark is 75%. Attendance at the entire course is a prerequisite to writing the exam.
- 3) If the course for which you have registered is cancelled by NBREA for any reason all registered students will then have the option to either reschedule for another course or cancel the registration and receive a full refund (less the cost of course materials). Please note that all materials are non-refundable.
