

One-Time Income Benefit of \$900 from Province of New Brunswick, an option for REALTORS®

Dear Members,

We received a strong impression by a senior provincial government official that those REALTORS® who <u>may need</u> income help during this challenging time should apply for the \$900 provincial income benefit. The income benefit is offered by the Government of New Brunswick, in partnership with the Canadian Red Cross. As many of you know, it is a one-time income benefit of \$900 available for workers <u>or self-employed</u> people residing in New Brunswick who have lost their job due to the state of emergency. The benefit will help to bridge the gap between when a person lost their job or closed their business <u>on or after</u> March 15, 2020, to when the national benefit takes effect. It's intended to be "bridge funding".

The senior provincial government contact encourages members who feel they need assistance, to follow and read the criteria for the \$900 Income benefit. Each member must <u>individually</u> decide if they are eligible for the benefit and if they want to pursue support.

Some members may have particular questions which they may need to seek clarification, on an individual basis with the government.

The government official we interviewed indicated that if a REALTOR® is having a closing coming past March 15, 2020 for example, there is no guarantee that the property will close. Until the lawyers, banks and others tell you it is complete, and you receive your commission, then it is not officially closed. This kind of scenario falls into "no income" which is <u>one</u> part of the provincial benefit criteria. As the government official





indicated to us, Members answer the funding criteria questions and you will be able to determine your eligibility. The program is intended to plug some holes in accessing Federal program funds for individuals.

If a REALTOR® does come into income funds post March 15th, it is simply a matter that would be addressed at the next income tax season. That kind of situation would be past this crisis period hopefully and you are back into a good cash flow basis.

This provincial income benefit will end on April 30, 2020.
